This request for expressions of interest follows the General Procurement Notice for this project that appeared in Development Business, issue no. 694 of 14th of January 2007.

The Government of Mozambique (GoM) has received a financing from the World Bank toward the cost of the Southern Africa Power Market (APL2), and it intends to apply part of the proceeds for consulting services.

The consulting services ("the Services") include the Work Supervision and Commissioning for the Design, Supply and Installation for the 220 kV Extension of Matambo Substation comprising new transformer 220/66/33kV with a capacity of 80/60/20 MVA with related transformer bay including civil works, earthing and other associated. The duration of the assignment is expected to take 18 (eighteen) months in maximum for the work supervision and commissioning followed by the Defects Notification Period with the duration of 12 (twelve) months for the all equipment and 24 (twenty-four) months for the Power Transformer.

The Electricidade de Mozambique now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are: description of similar assignments previously carried out; experience in similar conditions in SADC and in other regions and availability of appropriate skills among the key staff, etc.

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's Guidelines: Selection and Employment of Consultants [under IBRD Loans and IDA Credits & Grants] by World Bank Borrowers (May 2004, revision October 2006 edition).

Consultants may associate with other firms in the form of a joint venture or a subconsultancy to enhance their qualifications.

A Consultant will be selected in accordance with the QCBS (Quality-and Cost- Based selection) method set out in the Consultant Guidelines.
